## Message from the Director



In its second year of operations, the concept that perhaps best summarizes the work by the Observatory of Religious Freedom in Latin America – OLIRE – is “the multidimensionality of religious freedom.” With this concept, we allude to the fact that religious freedom has many dimensions that go far beyond political and academic debates on the relationship between religion and State, and conflicts between faiths. Religious freedom is also impacted by non-state actors, including certain illicit actors, peasant leaders, and social movements.

The OLIRE team, with support from its partners in the region, has been working on a titanic project, which analyses many of these dimensions, producing a large quantity of reports that have been presented at important academic forums, such as the *Red de Investigadores del Fenómeno Religioso* [Religious Researchers’ Network] in Mexico, and the International Studies Association. In addition, we have made contact with the representatives of various faith communities in the region, and provided them with our expertise and counsel. Our work has also made an impact on a political level. Our contribution to the report by the Foreign and Commonwealth Office in the United Kingdom on the persecution of Christians was a great feat, as was our participation at the Schönblick Conference in Germany.

The outlook on religious freedom in the region is bleak, but there is hope. For example, we have taken note of the Public Policy on Freedom of Religion and Worship in the municipality of Manizales (Colombia), which functions as an effective regional example of the promotion of religious freedom. In addition, a legislative initiative for the promotion of religious freedom is being pushed forward in the state of Hidalgo, Mexico, and a compendium of best practices for the resolution and prevention of religious conflicts is being prepared.

In 2020 we will continue working towards the promotion of religious freedom in the region. Our goals include sustaining our efforts to document incidents of violation of religious freedom in our database of violent incidents, enhancing our knowledge of the dynamics that threaten religious freedom, and intensifying our interaction with the Inter-American System of Human Rights. In addition to this, we will be launching an online and face-to-face training about the operationalization of religious freedom.

I encourage you all to stay informed of our activities at OLIRE, and to actively contribute to the effort being made to document the state of religious freedom in the region.

# The Role of the Inter-American System of Human Rights in the protection of the right to religious freedom



Due to its status as a fundamental right, the right to religious freedom has a reasonably good protective framework in each country in the region and in various international instruments. In the inter-American context, the American Declaration of the Rights and Duties of Man (1948), and the American Convention on Human Rights (1969) demonstrate that, *inter alia*, each person has the right to hold a religious belief freely, and to express and practice that belief in public and in private.

This inter-American framework includes the main protective agencies of fundamental rights, which have made reference to the right to religious freedom at different points in time. On the one hand, the Inter-American Commission on Human Rights – the IACHR – has placed particular emphasis on producing recommendations, annual reports, and special reports. On the other hand, we have the I/A Court H.R., which may not have passed a judgement directly related to the right to religious freedom, but has indirectly developed, or mentioned in isolation, a judgement during the production of advisory opinions. In other words, in the majority of the indicated instances, and unlike the Universal System for the Protection of Human Rights, or the European System of Human Rights, both the IACHR and the I/A Court H.R. have alluded to the right to religious freedom, but without elaborating upon its content, scope, dimensions, or related rights.

As the body in charge of monitoring the general human rights situation, as well as the one responsible for the promotion and recommendation of appropriate measures which contribute to the protection of the Member States themselves, and also as the first agency to receive, analyses, and investigate individual requests, the analysis and improvement of visibility of the right to religious freedom in various contexts of human and social development in the region falls to the IACHR, as does the identification of the numerous scenarios within which the right to religious freedom could be restricted upon directly or indirectly.

Although it is undeniable that the recognition of the right to religious freedom as a human right is an accomplishment, relevant means are needed to make it effective. At the inter-American level, this right is usually considered from a limited perspective, neglecting its multidimensional character, and therefore implying that it is difficult for it to be taken into consideration in the framework of a comprehensive study of the core human rights in the region, which puts the improvement of the guarantees that allow their realization and effective enforcement at risk.

In this sense, one of the objectives of OLIRE is to promote an integrated approach to the right to religious freedom at an inter-American level, making the recognition of existing and potential infringements/violations of this right possible; so member States are encouraged to fully implement the national and international obligations undertaken by each of them, in all areas relating to the various aspects of the right to religious freedom.

## About OLIRE

The Observatory of Religious Freedom in Latin America forms part of the Foundation Platform for Social Transformation, a non-profit organization registered in Voorburg, The Netherlands.

OLIRE is a platform for research, training, and advocacy, which has as its mission the promotion of religious freedom on the continent. It monitors and documents the position of vulnerable religious minorities whose rights are being infringed upon, looking to empower them so that they can increase their capacity for resilience in the face of hostilities and generate policy recommendations, which will enable them to improve their position when presenting them to decision makers.

We are therefore providing a space that allows an understanding and promotion of religious freedom from an academic, non-denominational, and non-partisan perspective, which makes it possible to strengthen the research of violations of religious freedom and the vulnerability of religious minorities in the region.

### ***Our line of approach***

#### *Monitoring*

OLIRE monitors the state of religious freedom in the region by documenting the incidents that violate religious freedom, and carrying out research related to the structural conditions that threaten it.

#### *Empowering*

Through the training of both people and organizations, particularly those that belong to religious minorities, we promote an improved understanding of the right to religious freedom, and an awareness of how to defend this right.

#### *Influencing*

We actively carry out advocacy work with the development of public policy recommendations for the effective protection of religious freedom, especially for religious minorities in different areas, and at all levels. We use means such as presentations to public and private organizations, podcasts, interviews, as well as other methods that enable us to inform decision makers.

# Incidents of physical violence as a violation of religious freedom

The core mission of OLIRE is to monitor the state of religious freedom in the region. Our research into religious freedom can be divided globally into two areas. The first area is the documentation of incidents of physical violence of violation of religious freedom. The second area is the analysis of other types of violence, such as discrimination, social exclusion, and various forms of pressure.

The tool we are using for the documentation of incidents of physical violence as a violation of religious freedom, is the [Violent Incidents Database-VID](#). This database is updated regularly by the OLIRE team in collaboration with our partners in the region, in accordance with specified [reference criteria](#).<sup>1</sup>

During 2019 a number of violent incidents were identified in the region, the majority of which involved members of Christian denominations (Catholic and/or Protestant). However, it is possible that there are cases linked to other religious denominations that were not reported.

Below, we detail the number of incidents registered on our platform. Given that this database is updated permanently, it is likely that other cases/countries in the region will be included subsequently:
